Directions from St. Louis, Missouri: From Highway 270, take Highway 55 South 21 miles to Highway 67 South (Exit 174). Take Highway 67 South Approximately 30 miles to the Leadington/Park Hills Exit (Highway 32). Make a Right onto Highway 32 and go 1.5 tenths of a mile to the first spotlight (Woodlawn Drive). Make a left onto Woodlawn Drive. Woodlawn Drive serves as the West Outer Road to Highway 67. Go approximately 2 miles to a stop sign (2-Way intersection) Make a left, go approximately 200 feet to the continuation of Woodlawn Road on your Right. Make a right and go approximately 2 tenths of a mile to fairgrounds entrance on the right. Directions from Ste Genevieve, Missouri: From Highway 55, take Highway 32 West approximately 22 miles to Farmington, Missouri. In Farmington make a Right onto Karsch Boulevard (Highway 32) and go through Farmington approximately 1.5 miles to Highway 67 SOUTH. Go South on Highway 67 approximately 2 tenths of a mile to the Maple Street Exit. At the end of the exit ramp (Stop Sign), go straight across Maple Street and onto Woodlawn Drive (West Outer Road). Directions from South: Highway 67 North to Farmington, Missouri exit (Maple Street). Make a left (West) onto Maple Street, go over Highway 67. Take Maple Street 2 tenths of a mile to Woodlawn Drive (West Outer Road) on Right. Make a Right onto Woodlawn Drive. Take Woodlawn Drive 2.2 miles to fair grounds entrance on the left (directions from east and south only). DIRECTIONS ALL WAYS: Horse trailer parking is on the West side of the arena, you will have to go around the arena to the South (left) side to get back to the trailer parking area. **ALL EXITS TO THE FAIRGROUNDS FROM HIGHWAY 67 HAVE BEEN REMOVED-PLEASE FOLLOW DIRECTIONS GIVEN!**
